



## **ODM CERTIFICATION PROGRAM**

The ODM Data Standard is increasingly recognised, as the ideal transport method for data across the entire clinical trial enterprise. In order to ensure consistency across toolsets and interoperability between ODM implementations, the ODM Certification Program has been developed.

### **The Importance of Certification**

In order to improve user confidence in the ODM and to ensure interoperability among available ODM toolsets, CDISC has initiated the ODM Certification program. This program is in direct response to requests from CDISC members. With Certification comes an increased level of confidence in the ODM standard, thereby increasing its adoption and use.

### **How to obtain Certification**

Assero Ltd has been selected as the service provider for the ODM Certification Program, as a result of an open RFP process. Assero Ltd can be found on the CDISC members' website:

### **The certification process is as follows:**

- Contact Julie Evans at CDISC [jevans@cdisc.org](mailto:jevans@cdisc.org) and register your interest
- Assero Ltd will contact you and assist with application. This initial consultation with Assero Ltd will determine whether both ODM import and export use cases are to be assessed
- Your application will then be lodged with CDISC
- Before consultation takes place, sample files should be sent to Assero Ltd in order for an informal check to be completed which ensures that time is used efficiently
- A day's off site preparation follows for planning and setting up tests
- Exhaustive on site tests are then conducted over two days to check your toolsets with results recorded and observations made
- Certification is completed off site with a fully documented report being produced for you
- The report is then communicated to interested parties
- The process will be repeated as necessary to obtain Certification

### **Benefits of Certification**

ODM Certification provides wide ranging benefits to the pharmaceutical industry as a whole, particularly to those companies who have already leveraged the standard or indeed those considering adoption.

#### *For FDA Regulated Product Manufacturers*

- Certification ensures that an ODM tool is making proper and consistent use of the standard.
- Certified tools and products give assurance of interoperability

#### *For Vendors and CROs*

- Certification of a vendor developed ODM tool will enable the vendor to provide a better quality, verified product to their pharmaceutical customers.
- Vendors can provide assurance that ODM toolsets are interoperable with other certified ODM tools.

**Charges for Undertaking Certification**

Initial Evaluations Charges:

This service has a fixed price of \$4800 plus expenses (hotel, flights etc). If an application does not achieve certification from the initial evaluation, additional evaluations will be charged at half the cost plus expenses. This charge covers the cost of achieving Certification status.

CDISC Charges:

Upon Certification being achieved companies will receive the right to use the Certification logo and be listed on the CDISC website. The charges are as follows:
