EXHIBITOR DATES

The exhibition for the CDISC Interchange 2013 will take place between **8am and 5pm on Wednesday 18 and Thursday 19 April 2012**. The booth set-up will start on Tuesday 17 April at 6.00 pm.



EXHIBITOR AREA

- The spacious exhibition area is located in the first floor of the Elite Hotel Marina Tower. There are several booth options as described next page.
- The exhibition area will be used for all coffee breaks in the morning and in the afternoon and for all lunches.
- Next to the exhibition area is located a huge room where the parallel streams of the conference will take place.

EXHIBITION COSTS

3 x 3 meter space cost:

- **Non-members:** **\$3000.00**
- **Members** **\$2400.00**



This includes 2 full conference registrations including 2 free tickets to evening event, 1 table, 2 chairs, and electrical supply. Additional expenses for services such as drayage, phone etc. will be available through the hotel at the cost of the exhibitor.

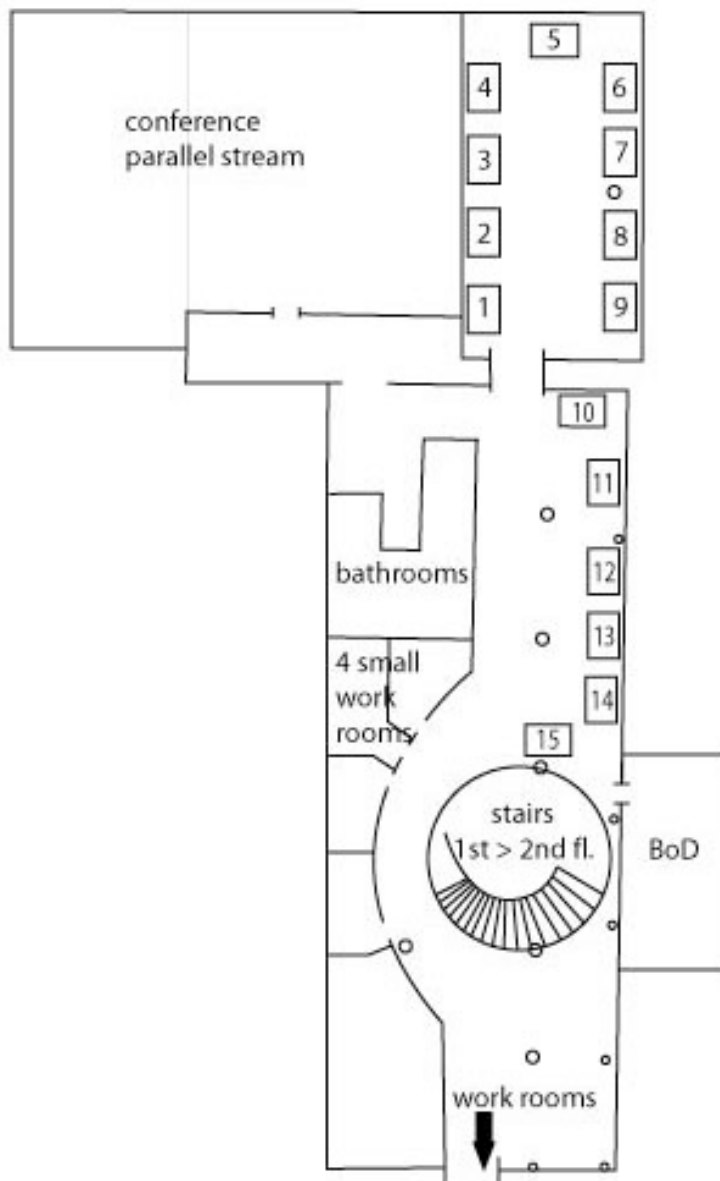
