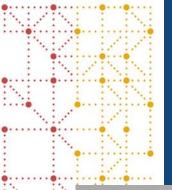

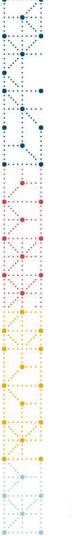

Current Requirements of ADaM Parameters

In the Basic Data Structure (BDS)

Current Requirement of ADaM Parameters

PARAM – Parameter

- The description of the analysis parameter.
- PARAM must include all descriptive and qualifying information relevant to the analysis purpose of the parameter.
- In contrast to SDTM --TEST, no additional variable is needed to further qualify PARAM.

PARAMCD – Parameter Code

- The short name of the analysis parameter in PARAM.
- There must be a one-to-one relationship between PARAM and PARAMCD within a dataset.

PARCATy - Parameter Category y

- A categorization of PARAM within a dataset.
- Note that PARCATy is not a qualifier for PARAM.
- PARAM to PARCATy is a many-to-one mapping; any given PARAM may be associated with at most one level of PARCATy.

History of Parameter Qualifiers

PARQUAL In Draft ADaMIG V1.2

PARAM - Parameter

- •The description of the analysis parameter.
- •PARAM should include all descriptive and qualifying information relevant to the analysis purpose of the parameter.
- •See the CDISC Notes for PARQUAL for possible exceptions regarding qualifying information.

PARAMCD – Parameter Code

- •The short name of the analysis parameter in PARAM.
- •There must be a one-to-one relationship between PARAM and PARAMCD within a dataset.

PARQUAL – Parameter Qualifier

- •PARQUAL can be used in addition to PARAM, as an alternative to creating a distinct value of PARAM for each level of a separate, categorical concept.
- PARQUAL provides qualifying information pertaining to PARAM
- that does not affect the meaning of PARAM.
- •PARAM must still uniquely and sufficiently describe what is contained in AVAL or AVALC.

After Public Review

Based on public review comments, PARQUAL was not sufficiently clear.

Options to address these comments:

- 1) modifying the current text
- 2) restricting the use of PARQUAL to a small list of permissible use cases
- 3) exploring alternate ways to address the underlying issue PARQUAL was seeking to address.
- Ultimately, the ADaM team decided
 - more time was required to evaluate PARQUAL
 - ADaM IG v1.2 moved forward without it

PARQUAL used to identify the source of the parameter

- INVESTIGATOR for investigator-based assessments
- CENTRAL for central imaging assessments
- PATHOLOGIC for an assessment by biopsy
- PROTOCOL for events affecting assessment

Neither of these use cases for PARQUAL is currently supported by the ADaMIG v1.3.



Proposed Parameter Qualifiers PARQUAL and PARTYPE

Proposal for Next ADaMIG Version

Allow PARQUAL but restrict use cases through addition of PARTYPE

PARTYPE governed by ADaM Controlled Terminology

• Starting with values "EVALUATOR" and "TREATMENT"

•Additions or changes to be requested via CDISC New Term Request Page

PARTYPE current working name and subject to change

• Other options: PARQTYPE, PQUALTYP

• Highlighting relationship to PARQUAL rather than PARAM

When PARTYPE and PARQUAL are used,

the combination of PARAM and PARQUAL must be sufficient to describe unambiguously the contents of AVAL/AVALC

In most cases PARAM/PARAMCD must be used alone

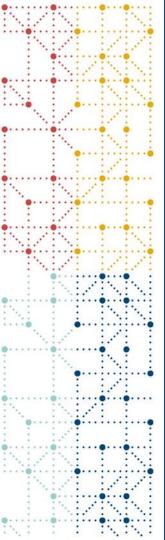

Invalid PARTYPE value, not in CT

Even with an allowed value of PARTYPE, PARQUAL cannot be used if PARAM is not the same across records

5.2 ADEVENT - Event Analysis Dataset

ADEVENT is a sponsor-defined analysis dataset following the ADaM Basic Data Structure (BDS). It's used as an intermediate dataset to support the primary efficacy analysis. The PARAMCD 'ASSESS' applies to different evaluators, with the variable PARQUAL used to differentiate the evaluators (INVESTIGATOR, CENTRAL). Variables that make a record unique for this dataset are USUBJID PARQUAL PARAMCD.

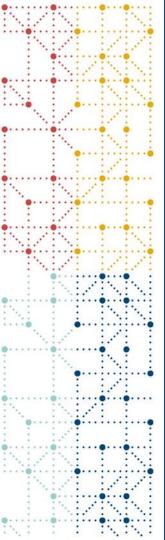

The conversation around possible PARAM qualifier variables has been around for years

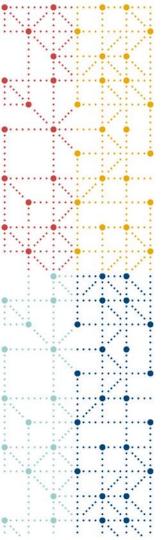
Limited use will soon be allowed
