- Therapeutic Area Support:

    - LOC: Misspelling in submission value 'CIRCUMFLEX, OBTUSE MARGINALS, LEFT POSTEROLETERAL AND LEFT POSTERIOR DESCENDING ARTERY BRANCHES'. Change to 'CIRCUMFLEX, OBTUSE MARGINALS, LEFT POSTEROLATERAL AND LEFT POSTERIOR DESCENDING ARTERY BRANCHES'
    - VSTEST-CD: For Temperature/TEMP (C25206), the intent of this term was to capture 'Body Temperature' and yet the original c-code assigned to this concept is defining temperature generically. Recent requests to add 'Core Body Temperature' and 'Peripheral Body Temperature' lead the team to consider updating the c-code.
      - Submission values will remain the same but the NCI c-code, CDISC synonyms, definition, and NCI Preferred Term will change.
    - RPTEST-CD: Removal of the Tanner Scale Test values: Tanner Scale for Boy, Genitalia Stage; Tanner Scale for Boy, Pubic Hair Stage; Tanner Scale for Girls, Breast Stage; Tanner Scale for Girls, Pubic Hair Stage ->
      - The Tanner scale terms previously in RPTEST-CD are being moved to the RS domain as clinical classifications.

- CDISC Glossary Team
  - No Additions or Changes being proposed for CDISC glossary this quarter.



- Laboratory Terminology Team
  - New Terms Added to Existing Codelists:

    - ONCRSR: C158264/MINIMAL RESPONSE is being retired from the codelist. It was determined by Oncology team and NCI-EVS that Minimal Response is synonymous with Minor Response (C123598), which is also in the codelist. Therefore C158624 will be merged into C123598. MR will remain as the submission value and 'Minimal Response' will be added as a synonym to C123598 to help with mapping.


